

ASIANEYE COMPOSITIONAL IMAGE LICENSE AGREEMENT

1 GENERAL

- 1.1 Welcome to the Asianeye Website (hereafter referred to as "Website"). The Website provides a free service whereby users can download Low Resolution Water Marked Comping Images (hereafter referred to as "Comping Image" or "Comping Images") for personal and non-commercial use to develop concepts, designs, prototypes and presentations for clients to aid in client's purchase decisions for commercial use.
- 1.2 Set forth in this Asianeye Compositional Image License Agreement (hereafter referred to as "Agreement") are the complete Terms and Conditions that govern you as an individual, and if you are using this Website on your employer's behalf or another third party (hereafter referred to as "Licensee"), your employer's or third party's use of Comping Images. Should you cease working for your employer or third party that licensed the Comping Image, the employer or third party may continue to use the Comping Images pursuant to this Agreement. However, you as an individual, may not make a copy or transfer any Comping Images to a new place of employment or to your own company.
- 1.3 These Terms and Conditions constitute a legal binding agreement between the Licensee and Asianeye Pte. Ltd. (hereafter referred to as "Asianeye"). Please read these Terms and Conditions in their entirety carefully before downloading and using Comping Images, as by using these Comping Images indicates that the Licensee accepts these Terms and Conditions in their entirety and agrees to be bound by the Terms and Conditions of this Compositional Image Agreement.
- 1.4 The Terms and Conditions set forth in this Agreement are in addition to the Terms and Conditions set forth in the ASIANEYE WEBSITE USAGE AGREEMENT which together constitute your entire binding agreement with Asianeye. If the Licensee does not agree to the Terms and Conditions in their entirety, discontinue usage of the Website immediately and do not download any Comping Images.
- 1.5 Asianeye reserves the right, at any time to revise these Terms and Conditions at its sole discretion by updating this page without notice. The Licensee should be aware that these Terms and Conditions are liable to update and usage of the Website and Comping Images will be subject to the most current version posted on the site at the time of the Licensee's use.

2 PROTECTION OF INTELLECTUAL PROPERTY

- 2.1 All elements including, but not limited to: captions, information, text, graphics, Comping Images, illustrations, moving images, sound and software (hereafter referred to as "Content") featured, displayed or contained on the Website, including the design are intellectual property and protected by trade dress, copyright, moral rights, trademark, the Berne Convention and other laws relating to intellectual property rights. Except as explicitly permitted under this or another Agreement with Asianeye, no portion or element of the Website or its Content may be copied, downloaded or retransmitted via any means. The Website, its Content and all related rights shall remain the exclusive property of Asianeye and its Content Providers.
- 2.2 Asianeye makes no representation that the Content or services provided on the Website are appropriate or available for use outside Singapore, and access to them from territories where their contents are illegal is prohibited. The Licensee may not use or copy or adapt or export or re-export any Content or services from the Website as to do so is a violation of applicable laws and regulations including without limitation United Kingdom, E.U. & U.S. export laws and regulations. If the Licensee chooses to access the Website from outside Singapore, it is done so on the Licensee's own initiative and the Licensee is responsible for compliance with applicable local laws.
- 2.3 "Asianeye" and the Asianeye logo are trademarks of Asianeye and are registered in certain countries.

3 GRANT OF COMPOSITIONAL LICENSE

- 3.1 Asianeye grants the Licensee a non-exclusive, non-transferable and non-sublicensable right to use any Comping Image, derivatives or copies downloaded from the Website or other Asianeye media. The Comping Images may only be used in for personal and non-commercial use to develop concepts, designs, prototypes and presentations for client approval.
- 3.2 One copy may be made for backup purposes only and that copy may be used only if the original Comping Image becomes defective, destroyed or otherwise irretrievably lost.
- 3.3 The Licensee accepts sole responsibility for the usage of any and all Comping Images alone or in combination with any other material.
- 3.4 The Licensee accepts that all copyrights and all rights of a proprietary nature and title to and in the Comping Images are the property of Asianeye and its contributors and are protected by international copyright laws, treaty provisions and all other applicable laws. Asianeye retains all rights not expressly granted by this Agreement. Use conferred is strictly limited by the Terms and Conditions of this Agreement and does not in any way transfer any copyright or proprietary rights to the Licensee.
- 3.5 Except for this limited, internal and evaluative use of the Comping Images, Asianeye grants you no other rights.
- 3.6 The License granted to the Licensee by Asianeye, as set forth in this Agreement will terminate automatically without notice from Asianeye if the Licensee fails to comply with any provision of this Agreement. Upon termination, the licensee must immediately stop using the Website, downloading and using Comping Images, return all copies to Asianeye and delete all occurrences from existing files.

4 UNAUTHORISED USE

- 4.1 Without limitation, it is STRICTLY PROHIBITED to use the Comping Images in the following ways:
- 4.1.1 for any other purpose than stated in clause 3.1-3.2
 - 4.1.2 as an example for another third party to recreate the content captured in the Comping Image in substantially the same manner
 - 4.1.3 to remove, reduce, deface, disassemble, reverse engineer, decompile or alter the watermark in any way
 - 4.1.4 to alter, add, insert, impose, modify or in any other way distort or amend that originally downloaded
 - 4.1.5 to expand the image pixel resolution beyond that originally downloaded
 - 4.1.6 to reduce image pixilation by any known method or mechanism
 - 4.1.7 to use the Comping Images in any way that could be regarded as obscene, derogatory, defamatory, blasphemous, unlawful purpose or pornographic
 - 4.1.8 to violate any person's right of privacy or publicity
 - 4.1.9 as a logo, tradename, trademark or servicemark
 - 4.1.10 to infringe upon any copyright, tradename, trademark or servicemark of any person or entity
 - 4.1.11 to distribute, sublicense or make available for commercial or non-commercial use
 - 4.1.12 to produce colour separations
 - 4.1.13 to produce any final electronic (on-line, broadcast or any other electronic distribution system) or printed output, materials, production or documentation distributed inside of the Licensee's company or outside of the Licensee's company or to the public.
 - 4.1.14 to produce or compile CD ROM materials
 - 4.1.15 to be placed on a server for public distribution
 - 4.1.16 to be shared by creating a disc library, storage jukebox, network configuration or similar arrangement
 - 4.1.17 to publish the Comping Images to more than 5 people in any form, electronic, traditional or otherwise
- 4.2 Unauthorised use of Comping Images constitutes copyright infringement and shall entitle Asianeye to exercise all rights and remedies under all applicable copyright laws, including but not limited to an injunction preventing further use and monetary damages against the Licensee and all unauthorised users and the beneficiaries of the use of such Comping Images. The foregoing is not a limiting statement of Asianeye's rights or remedies in connection with any unauthorised use.

5 INDEMNIFICATION

- 5.1 The Licensee shall indemnify, defend, hold harmless and keep Asianeye, its directors, shareholders, employees, trustees, agents, representatives, subsidiaries, affiliates, licensors, contributors and it's Content providers indemnified against any and all actions, proceedings, claims, liability, demands, losses, expenses, costs (including legal fees and expenses) awards or damages, incurred by any or all of them, either directly or indirectly as a result of:
- 5.1.1 the Licensee's use or misuse of the Comping Images alone or in combination with any other material,
 - 5.1.2 a result of the breach of any Terms and Conditions of this Agreement by the Licensee, no matter where such claims, demands or proceedings arise,
 - 5.1.3 the Licensee's failure to abide by any clause regarding the use of a Comping Image
 - 5.1.4 any claim by a third party relating to the use of a Comping Image alone or in combination with any other material.

6 DISCLAIMERS

- 6.1 The use of the Comping Images is at the Licensee's own risk. Asianeye supplies the Comping Images on an "as is" basis, and does not accept any responsibility or liability to the Licensee, or any other person or entity for any loss or costs or damages of any kind, direct or indirect, consequential or incidental arising out of the Licensee's use or inability to use the Comping Images.
- 6.2 Asianeye makes no warranty, express or implied regarding any Content, the Website, the accuracy of any information, or any rights or licenses under this Agreement including, without limitation, any implied warranties of merchantability or fitness for a particular purpose, or non-infringement, or that the Website or any services or Content will be uninterrupted or error-free.
- 6.3 The functions embedded on or in the Content contained within the Website are not warranted to be without defects, uninterrupted or without error. The Licensee, not Asianeye, assumes the entire cost of all necessary servicing, repair or correction due to Licensee's use of the Website and any Content.
- 6.4 Asianeye uses reasonable efforts to ensure the accuracy, completeness, correctness and reliability of the Comping Images featured on the Website, but makes no representations or warranties as to the Comping Images accuracy, completeness, correctness or reliability. Asianeye will not be held liable or responsible for any errors, inaccuracies or omissions in the Content displayed on the Website. It is the Licensee's responsibility to evaluate the accuracy, completeness, correctness and reliability of the Content made available on or through the Website before usage.
- 6.5 Except for any liability which cannot by law be excluded or limited, Asianeye or its directors or shareholders or employees or trustees or agents or representatives or subsidiaries or affiliates or licensors or contributors or it's Content providers shall not be liable to the Licensee or any other third party claiming through it for direct, indirect, incidental, special or consequential damages arising out of, or relating to the use of the Comping Images, whether framed as a breach of warranty or merchantability or fitness for a particular purpose or non-infringement, upon any legal theory, in tort, contract, failure of essential purpose or otherwise.

7 WARRANTIES

- 7.1 The Licensee accepts and warrants that the use of Comping Images shall not infringe any third party rights, of any nature, and any liability for the infringement of third party rights, of whatsoever nature, shall rest with the Licensee.
- 7.2 Asianeye warrants the Comping Images to be free from defects in material and workmanship for 30 days from initial delivery. The sole and exclusive remedy for a breach of the foregoing warranty is the digital replacement of the Comping Image at the option of Asianeye. Asianeye makes no other warranty, express or implied, including without limitation, any implied warranties of merchantability or fitness for a particular purpose. Asianeye or its contributors, employees, directors or shareholders shall not be liable to the Licensee or any other person or entity for any general, punitive, special, direct, indirect, consequential, incidental, lost profits, costs, losses or any other damages arising out of this license or otherwise.

8 NO WAIVER/SEVERABILITY

- 8.1 Asianeye reserves the right to change the Terms and Conditions of this Agreement without notice, at any time.
- 8.2 No actions by Asianeye, except an express written waiver or amendment, can be considered as a waiver or amendment of any clause contained within this Agreement.
- 8.3 Should any clause of this Agreement be found to be invalid, illegal or unenforceable in any respect, wherever possible this will not render ineffective any other clauses or terms contained in this Agreement and each will remain in full force and effect according to its Terms. Such clauses shall be amended only to the extent necessary to make the Agreement enforceable.

9 GOVERNING LAW AND VENUE

- 9.1 This Agreement shall be interpreted, construed and governed by the laws of Singapore. The venue for all disputes arising under this Agreement shall lie exclusively in the Courts and tribunals of Singapore and each party agrees not to contest the personal jurisdiction of these courts.
- 9.2 Any dispute arising from the use, by the Licensee, of the Website or from any Content derived thereof may be settled by binding arbitration.
- 9.3 Asianeye shall have the right to commence and prosecute any legal or equitable action or proceeding before any court of competent jurisdiction to obtain injunctive or other relief in the event that, in the opinion of Asianeye, such action is necessary or desirable.
- 9.4 In any dispute between Asianeye and the Licensee, Asianeye shall be entitled to recover reasonable attorney fees, legal expert fees and other expenses arising from the dispute from the Licensee.

10 ACCEPTANCE

The Terms and Conditions set forth in the Compositional Image Agreement relate to the Licensee's use of Asianeye's Comping Images. This Agreement and the Asianeye Website Use Agreement are a legal binding agreement and combine the entire understanding of the Licensee and Asianeye. Together they replace all other agreements, oral, written, implied or explicit. The Licensee hereby warrants that the Licensee has read and understood this Agreement and thus has the authority to enter into this binding Agreement either as an individual or on behalf of a company. If any provision of this Agreement is found invalid or unenforceable, the remainder of this Agreement shall remain valid and enforceable according to its terms. Accordingly, Asianeye and the Licensee agree that if any provisions are deemed not enforceable, they shall be deemed modified to the extent necessary to make them enforceable and in such manner as comes closest to the intentions of Asianeye and the Licensee to this Agreement as is possible. This Agreement will inure to the benefit of and be binding upon the Licensee and Asianeye, their successors and assignees, except that the Licensee may not assign or transfer this agreement without Asianeye's prior written consent. If the Licensee does not accept these Terms and Conditions, do not use the Asianeye Website or download and use any of its Comping Images.
